

# **WARWICKSHIRE AMATEUR SWIMMING ASSOCIATION**

## **CONDITIONS FOR THE AWARD OF SPEED SWIMMING RECORDS.**

**Revised on and effective from, 13 September 2009.**

- 1) Records may be claimed for all strokes and for all the recognised metric distances, in both short course (25m) and long course (50m) pools. To be eligible a competitor must have been a member of a Club affiliated to Warwickshire A.S.A. since the 1<sup>st</sup> of January in the year of the performance.
- 2) Open Records shall have no age limits. Junior Records will be awarded to competitors under the age of 16 on the day of the swim, for both long course and short course categories. In the longer term it is intended to replace the Junior long course category with Age Group Records for:- 13 and under, 14, 15, 16, 17, & 18 years; in order to harmonize with A.S.A. Law 505.2. However this will not occur until such time as the A.S.A. National Ranking Database is able to both identify and notify the Warwickshire A.S.A. of such times automatically.
- 3) Performances must be achieved under approved automatic electronic timing.
- 4) A competitor who is a member of a Club affiliated to Warwickshire A.S.A., and who is eligible to represent the Association but elects to swim for another County that year, cannot be accredited with an Association record.
- 5) The competitor or team must be entered in the name of a club affiliated to Warwickshire A.S.A. when recording the time concerned, or have been swimming in a representative team for which they have been nominated by Warwickshire A.S.A., or a club affiliated to it.
- 6) Results in Midland Regional and Warwickshire County Championships will be monitored and resulting records accepted for ratification without the need for claims to be submitted. From time to time the Records Officer will also monitor results at A.S.A / British Swimming sponsored National & International events, but to be certain any records resulting are not overlooked; use of the official claim form is recommended. All other claims must be made on the official form, obtainable from the Swimming Secretary, Records Officer; or from the County website. This must be completed and returned to the Records Officer within 28 days of the performance, together with proof as indicated. ([www.warwickshireswimming.org.uk](http://www.warwickshireswimming.org.uk)).
- 7) Records will be credited against the club in whose name entry to the competition has been made; or:-
- 8) If achieved in representative competition\*, against the name of the competitor's 'rank' club as shown on the ASA registration database on the day of the swim or as soon as possible thereafter. The 'rank' club must also be affiliated to Warwickshire ASA.
- 9) In all cases eligibility will require the competitor's 'fee paying club', as shown on the ASA registration database; to be a club affiliated to Warwickshire ASA.
- 10) All record claims will be subject to ratification by the Records Officer, who shall also decide on any issue of eligibility not covered by the above.

**N.B.** \* Representative competition is defined as any English Schools Swimming Association (ESSA) or British Universities & Colleges Sport (BUCS) competition, any Inter-County or Inter-Regional competition, any competition anywhere in the World when competing as a member of a GB or England team; or any overseas competition when temporarily based overseas.
